Improving the quality and transparency of implementation study reporting: a consolidation of reporting guidelines relevant to implementation studies

About this resource

This resource is a consolidation of reporting guidelines relevant to implementation studies. A reporting guideline is defined as "a checklist, flow diagram, or structured text to guide authors in reporting a specific type of research, developed using explicit methodology," by the Enhancing the QUAlity and Transparency Of health Research (EQUATOR) network.

This resource has been developed by researchers in the Centre for Implementation Science at King's College London and King's Improvement Science. The development of this resource has been led by the National Institute for Health Research Applied Research Collaboration South London (NIHR ARC South London) at King's College Hospital NHS Foundation Trust and supported by King's Improvement Science.

Several reporting guidelines have been developed to improve the reporting of implementation studies. However, a list containing all reporting guidelines relevant to implementation studies does not currently exist, leaving implementation research teams and practitioners working within the field to search and identify relevant reporting guidelines listed on the EQUATOR Database of Reporting Guidelines and elsewhere. This resource aims to fill this gap.

How this resource was developed

We screened more than 570 reporting guidelines listed on the EQUATOR Database of Reporting Guidelines, identifying 28 guidelines relevant to the reporting of implementation studies. In addition, based on our knowledge of the literature, we identified three additional resources containing recommendations relating to the reporting of specific elements of implementation studies.

This resource aims to:

Support implementation research teams and practitioners working in the field identify reporting guidelines relevant to implementation studies and, in turn, improve the quality and transparency of implementation study reporting.

Who is this resource for?

Research teams and practitioners from varying disciplines working to study or evaluate the implementation of evidence-based interventions.

General reporting guidelines

Standards for Reporting Implementation Studies (StaRI) Statement.
